Dear Norwalk Ski Club Members,

This notification is a reminder that the NSC Annual Membership Application and Renewal form, together with Membership dues, are **due by July 1st** prior to each new ski season. This letter serves to clarify renewal deadlines, related late fees, and risk for loss of membership status should your renewal be late.

The NSC Board hopes you will decide to rejoin! But we do need renewals to arrive in a timely manner so we can plan and prepare for the upcoming ski season.

This notification is a reminder that the **NSC Annual Membership Application and Renewal form**, together with **Membership dues deadline: July 1st, prior to each new ski season. Please note: ALL members are required to validate their Membership applications with their signature.**

- **If your dues are not received by August 1st**, (30 days late), **will be charged an additional late fee of \$25.**
- **If your dues are not received by September 1st**, (60 days late), priority will go to new membership applications on the current Waiting List, **and you will be charged an additional late fee of \$50.**
- **Membership Renewals received after September 30th**, **will be subject to a late fee of \$50.** and will be placed at the bottom of the current Waiting List.
- **If the renewing member does not make it off the Waiting List** during the current season, their renewal dues will be refunded for the lodge portion only.
